Benefits of Renting to a HUD/VASH Veteran

- VA staff provide Veterans with frequent in-home case management
- VA staff serve as a liaison between the Veteran and landlord in order to ensure housing is maintained
- Monthly rental payments from the local public housing authority (PHA)
- Veterans have access to an employment coordinator and wrap - around programs within the VAMC
- Help honor Veterans who have served our nation

What is HUD/VASH?

Department of Housing and Urban Development (HUD)

HUD: Housing Choice Voucher Program (Section 8)

VASH: Veterans Affairs Supportive Housing by the VA Medical Center

HUD/VASH is a partnership. HUD provides a Section 8 voucher to our Veterans. VASH helps provide frequent in-home case management.

Examples of case management include:

- Reinforce being a good neighbor and tenant
- Assist with housing stability
- Provide help with personal goals
- Access to community resources that assist with rent and utility payments

Veteran Homelessness

The 2016 Point-in-Time (PIT) count revealed that there were about 39,471 homeless Veterans on a single night. These Vets are sleeping under bridges, in alleys, in abandoned buildings, or living in shelters.

Even one Veteran without safe and stable housing is one too many!

In response to this problem, the VA started HUD/VASH along with other programs. The goal is to break the cycle of homelessness and connect Veterans with long-term stable housing.
