**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

If using Project-Based Vouchers (PBVs), provide the projected number of project-based units and general locations, and describe how project basing would be consistent with the PHA Plan.</p> <p>CMHA intends to apply to SAC to dispose of 20 of its 54 scattered site public housing units (OH038051967 Clermont Woods) through Section 18 of the 1937 Act (42 U.S.C. 1437p). These units are being disposed of due to distance between the units and lack of uniformity of systems as well as disposition is in the best interest of the residents as it permits the purchase and development of new construction or rehabbed property to be operated as low-income housing. Most of the units intended for disposition also either have structural issues, system issues, or outdated septic systems which are reaching the end of their life use. Pursuant to 24 CFR 903.7(h), the 19 units are identified as: 2212 Berry Rd, 3164 Lindale Mt Holly, 2875 Batavia Williamsburg Pike, 4146 St Rt 276, 128 S Ash, 215 Holly Rd, 231 N Main St, 274 E Plane St, 3411 Sr 774, 3507 Inez, 497 Glenrose, 1817 Loise Lane, 2340 Cedarville, 2358 SR 131, 6036 Belfast Rd, 6019 Ring Lane, 2055 Harvey Rd, 169 Wilmar, 2635 Runway and 349 S Fourth St. CMHA intends to submit the application to SAC and prepare to dispose of the properties at Fair Market Values within the next 12 – 24 months. The proceeds from these sales will be used to developed new low-income public housing units to replace the disposed units while maximizing the agency's fair cloth space. Additionally, CMHA will seek Tenant Protection Vouchers (TPV) for the families that are impacted and assist with relocation efforts as required by 24 CFR 970.21.</p> <p>CMHA has awarded through a competitive process Project Based Vouchers to Clermont Housing Corporation (CHC), which is the non-profit entity owned by the PHA, to be placed at Batavia Meadows (21 units) located in Batavia, OH and Highview (15 units) located in Milford, OH which are still subject to HUD approval. Environmental Reviews for both complexes have been submitted to Clermont County for review. After final approval is given by HUD, the existing families will be briefed and screened for the PBV HAP contract to be executed for existing housing units. Additionally, CMHA will continue to seek partnerships for other PBV opportunities by fostering partnerships with agencies and organizations with an emphasis on serving the hardest to house populations (VAWA, Domestic Violence, Homeless, Disabled, Elderly).</p> <p>CMHA will apply for the Safety and Security Grant when they are offered to help secure additional funding to improve the lighting and security systems at our family and elderly sites. Additionally, CMHA is applying for Community Development Block Grants (CDBG) to secure additional funding to improve the driveways and sidewalks at all multi-family sites.</p>					

	<p>CMHA may pursue RAD conversion efforts to convert some of the remaining Public Housing units to either PBV or PBRA. CMHA may also seek to pursue Streamlined Voluntary Conversion (SVC) since we qualify under the Small PHA Designation.</p> <p>As part of our Capital Fund Projects, CMHA intends to submit a Development and Acquisition Plan to convert the unused Community Center at Monroe Woods (non-dwelling structure) into multiple ADA units that will be fully accessible.</p>

CMHA will continue to update procedures and checklists to ensure continued compliance with HUD rules and regulations. CMHA's website has been updated to permit ease of access for families apply for our programs and permit ease of use for participant programs who are currently participating with our programs (i.e. Forms, program rules, landlords lists, and information about how our programs work, etc.) Developed a preventative maintenance schedule, a fleet maintenance schedule, updated personnel policies, drafted standard operating procedures, continued staff training, updated finance procedures with regards to compliance and procurement requirements. A new board member was recruited and filled the vacant seat. Began doing the mobile work orders through the current software to generate better tracking and statistical reporting. Created Memorandums of Understanding with a fifth social service/provider in Clermont County. In FY 2023, CMHA plans to add a sixth social service/provider in Clermont County if approved by the Board and HUD with this Annual Plan. Met with HUD to discuss RAD Conversion, Streamline Voluntary Conversion and Disposition of Public Housing Units</p>

The finding was for Allowable Costs and Cost Principles. The Authority did not have a proper cost allocation method and had other unallowable expenditures. A 60/40 split was used, paying 40% of indirect costs from the Housing Choice Voucher Program and 60% from the Public and Indian Housing Program. This is not an allowable cost allocation under the requirements. The Field Office was aware of this issue and has worked with CMHA and the Ohio Auditor of State (AOS) to address the cost allocation plan and to repay public housing the ineligible public housing expenses HUD identified in its report dated October 25, 2019. In January 2022, CMHA has repaid the funds to HUD by selling non-public housing properties it purchased through its non-profit, Clermont Housing Corporation (CHC). Based on this information, HUD indicated in correspondence dated October 26, 2021, that this item is considered closed when CMHA's actions are closed by the auditors or CMHA has repaid public housing, whichever comes first.</p> <p>(c) The FDS 2020 is still ongoing with the Ohio Auditor of State.</p>
