 - d. Bid results are available in the CMHA Administrative Office on the day following the bid openings for any interested party that may wish to review them.

e. Equal or Tie Bids. CMHA reserves the right to award at their discretion to any one of the tie bidders where it is most advantageous for CMHA to do so.

- 2. Bidders shall complete and sign all documents included with the bid package. Failure to do so may be cause for rejection.
- 3. Insert prices for furnishing all the material described or required per vehicle for CMHA to determine the number of vehicles to be purchased within the available budget. Prices shall include any charges for packing and all transportation charges fully prepaid by the contractor F.O.B. destination and placement at locations specified by the CMHA. No additional charges will be allowed for any transportation costs resulting from partial shipments made at the vendor's convenience when a single shipment is ordered.
- 4. Payments will be made upon the delivery of the Motor Vehicles by the successful bidders. CMHA is tax exempt from any State or Federal sales tax. CMHA will not pay interest, sales taxes, or late fees regardless of language provided.
- 5. If there is a discrepancy between the unit prices and the extended totals, the unit prices shall prevail. In the event there is an error of the summation of the extended totals, the computation by the OWNER of the extended totals shall govern.
- 6. Award will be made by CMHA within thirty (30) days after receipt of bids.
- 7. Vehicle delivery shall be made upon receipt of a Purchase Order issued by CMHA, unless otherwise negotiated.
- 8. There will be no trade in vehicles.
- 9. Unless otherwise indicated, a minimum of one operator's manual for each vehicle will be provided to CMHA.

WARRANTY

All warranty paperwork will be supplied with each unit at the time of delivery. The vendor shall furnish for each vehicle delivered, all the manufacturer's standard warranty against defects in material, workmanship, and design in said vehicles. This agreement shall cover all warranty work, minor warranty, and service work at the successful bidder's location.

MODEL INFORMATION REQUIRED

Unless otherwise stated, the use of manufacturers' names and product numbers are for descriptive purposes and establishing general quality levels only. **They are not intended to be restrictive.** Bidders are required to state exactly what they intend to furnish, otherwise it is fully understood that they shall furnish all items as stated.

1. The manufacturer, make and exact models proposed as substitutes shall also be submitted on bidder's letterhead with any proposal contended to be "equivalent". The vehicles, equipment and accessories shall be new. For purpose of evaluation where an equivalent product is being furnished, bidder must indicate any variation to our specifications no matter how slight. If no variations are indicated, it will be construed that the bid fully complies with the specifications.

2. CMHA will consider any request for a contract roll-over to the next model year after the passing of the vehicle manufacturer's cut-off date, at the same contract pricing, specifications, terms, and conditions or better.

KEYS

A minimum of three (3) sets of keys are required with each vehicle ordered.

TITLES

Each vehicle must be delivered with an Ohio motor vehicle new vehicle inspection sticker in place as prescribed by law. Each vehicle must also be delivered with a 30-day temporary plate.

DELIVERY REQUIREMENT

- 2. No vehicle will be accepted at the final delivery point without all supporting documentation completed and delivered with the units, which include the vehicle title, warranty, invoice, and keys sets.
- 3. Manufacturer's standard items, such as hubcaps, rubber or vinyl floor mats, jack and lug wrench or the like, shall be provided, installed, by the contractor prior to delivery.
