CLERMONT METROPOLITAN HOUSING AUTHORITY (CMHA) LANDLORD LEASE-UP INCENTIVE BONUS PROGRAM

EFFECTIVE 4/1/2024 to 12/31/2024

Did you know? CMHA's Housing Choice Voucher (HCV) Program pays local landlords nearly **\$590,000 a month** through Housing Assistance Payments (HAP), commonly referred to as subsidy. This subsidy provides housing for *up to* 993 HCV families located throughout Clermont County. To be successful in this endeavor, CMHA needs landlords *like you* who are willing to provide our families with quality housing.

What is the HCV Program? The HCV program is a federal program for assisting very low-income families, the elderly, and the disabled to afford decent, safe, and sanitary housing in the private market. Since housing subsidy is provided on behalf of the family, participants are free to choose any housing which meets the requirements of the program from the open market.

What is a Housing Subsidy? A housing subsidy is the portion paid monthly by CMHA directly to the landlord on behalf of a participating family. The subsidy is paid monthly via direct deposit.

What is the Tenant Rent? The tenant rent is the portion a family contributes toward their rent. The HCV program is an income-based program, which means that the tenant's portion is based on their rent. A tenant is required to pay a minimum of 30% of their adjusted gross income but not to exceed 40% of their adjusted gross income to rent and utilities.

Housing Subsidy + Tenant Rent = Contract Rent

Why is the incentive being offered? This bonus is to provide an inducement to landlords to participate in our program.

How much is the incentive being offered? The incentive is based on the chart below. The bedroom size of the unit or the family's voucher (*whichever is lower*) will be used to determine the "bedroom size" below. This one time "Lease-Up Incentive" bonus will be paid to landlords for eligible families who leased up after 4/1/2024 and prior to 12/31/2024.
